### **PRICES:**

Net unless otherwise stated. Typically we only adjust pricing in conjunction with raw material increases, although we reserve the right to change without notice.

### **CURRENCY:**

USD unless otherwise stated

### **TERMS:**

Credit Card, Wire Transfer or Firm Net 30 Days where offered

### **FOB:**

Shipping point (Stock in Cypress, TX)

### **MINIMUM ORDER:**

\$100 product total except for Torlon Balls, which is \$50.00.

### **CUTTING CHARGE:**

\$10.00 per cut of non-standard lengths

### **EXPORT ORDERS:**

Canada & Mexico- \$15.00 Document fee for orders less than \$1,000.00  
All other countries- \$35.00 Document fee for orders less than \$1,000.00  
(No Document fee for orders over \$1000)

### **CUSTOM AND MADE TO ORDER (MTO) ITEMS:**

A 50% deposit is normally required on custom parts or MTO items. If orders for custom or MTO items are cancelled before completion, the customer will be liable for the pro-rated progress on their contract. If complete, the full amount of the contract shall be due.

### **RETURN GOODS:**
